

# Connexional Updates

## New Consent Forms - Use of Photography or Video

Updated consent forms for the use of photography and video are now available on the website: Forms ([methodist.org.uk](http://methodist.org.uk)). There are two consent forms, one for parents and carers, and one for young people thirteen and over.

These forms have been updated to ensure that our consent obligations are increased and to include reference to our privacy policy as well as to reflect a change in legal age of young person's consent.

For young people thirteen and over, both the young person and the parent or carer will be asked for consent, while for those twelve and under, a parent or carer will need to consent on their behalf.


### DBS ID Checking Guidelines

Guidance to help you validate the identity of a DBS check applicant and a new lead/counter signatory.

### DBS new customer webchat service

This provides a way for customers to get answers to ordinary questions in real time from customer service staff, without having to call the customer contact centre

The service will operate Monday to Friday, 10am to 4pm, and is available to answer general customer questions, to anyone completing a task such as applying for a DBS check, making a barring referral, or logging into the Update Service.

## Methodist Conference

### Safeguarding Committee Report

The Revd Henry Lewis's report to Conference speaks of the ongoing actions undertaken to strengthen the Church's safeguarding work and response to the IICSA report on safeguarding within religious organisations, particularly in respect of safer recruitment, training and policy development.

It also recognises the impacts of the proposed District boundary reviews and the intention to align, for example, stationing committees, learning network areas and safeguarding sectors.

## Update

The Conference voted not to receive proposals which aimed to reduce the number of districts and subsequent resolutions were withdrawn. A number of districts have already started work on boundary changes and these will be considered by the Methodist Council.

### New ways of Oversight and Trusteeship

The Methodist Conference has approved new processes of oversight and trusteeship aimed towards reflecting more accurately the size of the church and reducing the weight of administration on districts and circuits.

The Conference voted to reduce the size and duration of the Conference and also to establish a new trustee body, the Connexional Council, which will replace the Methodist Council and the Strategy and Resources committee.

The Connexional Council will be the charity trustee body and have general control and management of the Connexional administration of the Methodist Church, reporting annually to the Charity Commission.

It will consist of around twenty people in order to be small enough to be agile and flexible and large enough to allow different views and balance.

The number of Conference representatives will drop from 306 to 225.

# Safeguarding News

## Extension of position of trust provisions

The “position of trust” offences within sections 16 – 19 of the Sexual Offences Act 2003 have been extended to include those that lead activities in sporting and religious settings..

Those who conduct certain activities within a religious context frequently have significant influence over a young person’s spiritual and religious development, often against a background of emotional vulnerability or immaturity.

This leads to extremely high levels of trust, influence, power and authority and religious leaders are well established, trusted and respected in the community.

## Safeguarding for Trustees of User-led Organisations (ULO)

This guide, published by SCIE February 2022, is about safeguarding responsibilities as a trustee of a user-led organisation (ULO). Trustees have a duty of care to staff, service users and volunteers and need to be assured that good safeguarding practice is in place in the organisation.

The guidance includes:

- The role of all trustees regarding safeguarding.
- The law on safeguarding children, young people, and adults with care and support needs.
- Having a safeguarding strategy, policies, and procedures including reporting safeguarding concerns and management of allegations made against trustees, staff, and volunteers.
- Identifying a safeguarding lead and what the role should involve.
- Using a risk assessment to identify where safeguarding can be improved.
- Developing an open, honest culture
- The importance of good record keeping.
- Reporting to regulatory bodies such as the Charity Commission.

- Partnership working with other organisations and agencies.
- Staff training on safeguarding and whistleblowing.
- How to monitor safeguarding activity.



## Impact of immigration

Greater Manchester Immigration Aid Unit has published a report looking into the impacts of the reporting condition on families, children and young people in Greater Manchester who have migrated to the UK.

'Reporting' requires people who are on 'immigration bail,' after being released from detention by the Home Office on immigration matters, to regularly sign in at an immigration reporting centre.

The effects of reporting include:

- living with uncertainty
- feeling helpless
- a negative impact on mental wellbeing
- a negative impact on parenting
